

# Privacy Policy

This Privacy Policy describes the ways in which **WeRobotics** (“we,” “our,” or “us”) collects, uses, and discloses information about you obtained through [WeRobotics.org](http://WeRobotics.org); our Google Group, Google Forms, Webinars, Online Training and all other WeRobotics websites or online services that link to this policy (collectively, the “Site”) as a user of the Site. By using the Site, you consent to the processing of your information as set forth in this Privacy Policy, now and as amended by us.

## What information do we collect?

Information You Provide – We collect any information that you provide when you use the Site, including when you create an account, upload information or documents; participate in the Site, sign up to receive our electronic newsletters, or otherwise contact us with a question, comment, or request. This can include, but is not limited to, (a) your name, contact information, username, password, and other registration information; (b) personally identifiable information including household information, and payment card information; (c) information you provide when you upload data to the Site; and (d) information you provide us when you contact us.

The information you provide may also include information that you as a user of the Site provide about other individuals. Please note that information about such other individuals is used by us only as necessary to perform our work and we do not use or disclose the information for marketing or promotional purposes or for other discretionary purposes.

You represent that you have any required permissions to collect and provide the data you are uploading to the Site and that ***you are in compliance with applicable laws regarding such data.***

Information Automatically Collected From You – We may automatically collect certain technical information from your computer when you use the Site, such as your Internet Protocol address, your browser type, your operating system, the pages you view on the Site, the pages you view immediately before and after you access the Site, and the search terms you enter on the Site. This information allows us to recognize you if you return to the Site using the same computer, or mobile device, and to improve the Site and the services we provide. We and our service providers may collect this information using “cookies,” which are small text files that the Site saves on your computer using your web browser and accesses when you return, or similar technologies.

### **How do we use this information?**

We may use the information we collect for a number of purposes, including, but not limited to:

- creating and providing reports and information on our work and projects;
- providing you with information about the Site or required notices;
- allowing us to improve the Site and the services we provide, such as by better tailoring our content to our users' needs and preferences;
- generating and analyzing statistics about your use of the Site; and
- detecting, preventing, and responding to fraud, intellectual property infringement, violations of our Terms of Use, violations of law, or other misuse of the Site.

We also may combine or aggregate any of the information we collect through the Site or elsewhere for any of these purposes.

### **Under what circumstances do we disclose this information?**

We may disclose the information we collect through the Site:

- to create reports on the data collected
- to affiliates, partners, and service providers who work on our behalf and who operate consistent with this Privacy Policy, including, but not limited to, service providers who: collect and upload data to the Site; create data sets; or provide payment processing services
- as required by applicable law, such as to comply with a subpoena or other legal process, or to comply with government reporting obligations;
- when we believe in good faith that disclosure is necessary (a) to protect our rights, the integrity of the Site, or your safety or the safety of others, or (b) to detect, prevent, or respond to fraud, intellectual property infringement, violations of our Terms of Use, violations of law, or other misuse of the Site;.

In addition, we may share aggregate reports on user demographics and traffic patterns, as well as de-identified information, with third parties.

The Site also may contain links to websites published by third parties. You acknowledge and agree that we are not responsible for the collection and use of your information by such websites that are not under our control. We encourage you to review the privacy policies of each website you visit.

### **Where is this information stored?**

Information collected through the Site will be processed in and subject to the laws of the United States, which may not provide the same level protection for your personal information as your home country, and may be available to the United States government or its agencies under a lawful order made in the United States. In addition, we may transfer and store your information outside the United States to our affiliates, business partners, and service providers located in other countries that may not be your home country. By using the Site, you consent to such transfer to, and processing in, the United States or other countries.



### **How is your information secured?**

We maintain administrative, technical, and physical safeguards designed to safeguard the information collected by the Site. However, no information system can be 100% secure, so we cannot guarantee the absolute security of your information. Moreover, we are not responsible for the security of information you transmit to the Site over networks that we do not control, including the Internet and wireless networks.

### **Your choices**
